236 BOROUGH AND COUNTY COUNCILLORS REPORTS

Cllr Owen reported that micro ash felt (not a full resurfacing) has been used to repair Ryslip Close, Armond Close area. Repair to Victoria Street was in the pipeline.

Cllr Plumb asked if Babbington street lighting could be made more in keeping with the village environment.

Cllr Warner asked if there were plans to deal with Station Road, Valley Road and Kimberley Close. Cllr Owen will put in a request for the next financial year.

Cllr Samuals asked if the wattage on street lighting is known. Cllr Owen did not know but stated that there is an ongoing programme to change to LED lighting; the priority is being given to get rid of sodium lighting.

Cllr Clark asked if there was any news regarding re surfacing of High Spannia, Cllr Owen is hopeful this can be added to the programme. At the moment he has not seen next year's programme.

Borough Cllr Easom stated that hedges are being laid with some planting on Hall Om Wong.

Cllr Easom has received some complaints regarding the demolition and clearance of the site on Eastwood Road. Broxtowe BC are investigating this. Mr P Chandwick owns the land and is clearing rubbish and any self-set trees. It is thought that the site will be available for housing subject to any planning application.

Cllr Warner is hoping to supply Cllr Easom with a copy of TPO report produced by Liberal Democrats some time ago in relation to the Brewery Site.

Cllr Plumb thanked Cllr Owen in his efforts regarding the Babbington issues.
