

## Section 3 – External Auditor Report and Certificate 2020/21

In respect of **KIMBERLEY TOWN COUNCIL – NT0099**

### 1 Respective responsibilities of the body and the auditor

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2021; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

### 2 External auditor report 2020/21

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Information has come to our attention from the internal auditor highlighting the fact that documents in respect of 2019/20 were not published on the authority's website by the dates specified in the Accounts and Audit Regulations 2015

Other matters not affecting our opinion which we draw to the attention of the authority:

The smaller authority has not provided:

- evidence that the smaller authority is registered as an employer with HMRC.

The smaller authority has not yet resolved the issues around trust funds, as highlighted in the internal auditor's detailed report. It should ensure that these issues are resolved as soon as possible.
