EV/24/109 Events Budget

The Events Budget for 2024-2025 was discussed in detail. The following amendments were agreed and will be taken to the Finance meeting on  $18^{\rm th}$ 

January 2024:

Party in the Park - PA systems and prizes to be removed. Total reduced to £3,650.

Remembrance Parade - Music provision reduced to £200. Purchase of lamp post poppies added in at £250. Total reduced to £3,250 plus £50 to Royal British Legion.

Christmas Lights Switch-on - Light Technician reduced to £6,000. Event cost, after grant from Broxtowe Borough Council, reduced to £1,100.

Valentine's 2025 - Banners added in at £1,000. Balloons and helium added in at £600. Leaflets/Lotto tickets added in at £100. Total increased to £3,700. All other events to remain the same.

A provision needs adding in for a card reader, prices to be obtained.
