## EV/24/005 Fairground Update

A request has been received to hold a children's funfair on Knowle Park. It was **resolved** to follow up with residents and other stakeholders. To look at alternative possibilities of holding the funfair on the school playing fields or the farm land at Swingate, and revisit the possibility of holding it at Watnall.

#### EV/24/006 <u>D-Day Beacons</u>

It was agreed to invite Darren Henry, the Kimberley Broxtowe Councillors and the press to the D-Day events on 6<sup>th</sup> June 2024.

The Chapel on the Hill will be decorated with bunting, etc. D-Day commentary to be streamed. To look into getting some War memorabilia displayed.

Cllr T Rood to make arrangements with the Town Crier.

The poster was approved with one small amendment.

The Risk Assessment and Event Management Plan need to be finalised.

### EV/24/007 Party in the Park - Medieval Madness

Barlows, funfair rides and a vegan food van have all confirmed they will be in attendance. There will also be a Magikal Market, eleven stall holders have confirmed so far, gazebos will be erected for them. Cllr S Boneham to send bank details to all stall holders/ food vans for payment of their fees. He will also see if he can book a doughnut stall.

The promotional materials were approved with a couple of amendments.

It was **resolved** to put a request to Full Council for the purchase of a Square card reader at £149. There are no monthly fees involved, a 1.75% fee will be payable on all transactions. The Square terminal has the advantage of still working offline.

It was **resolved** to purchase a hand stamp for anyone wishing to leave the site and reenter later.

Cllr T Rood to book a Cherry Picker for the over street banner.

It was agreed we need a better system for separating the rubbish for recycling. Cllr N Doherty will monitor it on the day.

The Clerk to book St John Ambulance.
